



**SHOP AND WIN a Fresh Food Easter Hamper!**  
**Terms and Conditions**

1. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is the manager of The Dianella Plaza Shopping Centre, Greenpool Management Co Pty Ltd ACN 646 523 122 of C/o: Dianella Plaza Shopping Centre, 366 Grand Promenade, Dianella WA 6059 (**"Promoter"**).
3. Entry is only open to WA residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, Dianella Plaza Shopping Centre, tenants, and their employees (and their immediate families) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de facto spouse, child or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister, or first cousin.
5. This Promotion will be conducted at the Dianella Plaza Shopping Centre, 366 Grand Promenade, Dianella WA 6059 (**"Centre"**).
6. The promotion commences on Tuesday, April 1<sup>st</sup>, 2025, at 9:00 a.m. (WST) and runs until Wednesday, April 17<sup>th</sup>, 2025, at 11.59 p.m. (WST) (**"Promotional Period"**).
7. To enter the **Promotion**, individuals must complete the following steps during the Promotional Period:
  - a. Spend over \$60 at any specialty store, or over \$120 from a major store (Coles or Woolworths) in one transaction at Dianella Plaza (not including alcohol, tobacco, vape equipment, weapons, gambling, purchase of gift cards, cosmetic or surgical procedures, or medicines).
  - b. Complete the competition form and attach one receipt as a scanned document or photo on the Dianella Plaza website competition page.
  - c. One receipt per entry permitted.
  - d. Receipts must clearly display the Dianella Plaza retailer name, transaction amount and transaction date.
  - e. The date of purchase/s must be within the Promotion Period referenced in Section 6.
  - f. Entry forms must be completed in full, including name, contact phone number, email address, and postcode.
  - g. Entrants must agree to subscribe to the Dianella Plaza Centre emailing list using the check box on the entry form. Entrants can unsubscribe from the mailing list anytime using the "unsubscribe" option on any future marketing correspondence received from the Promoter.
  - h. Entrants must ensure receipts are kept as they will be required as proof of purchase to collect the prize.
8. Incomplete, indecipherable, or illegible entries will be deemed invalid.
9. Multiple entries are permitted, provided that each entry is submitted separately and in accordance with all entry requirements. A single entry is permitted per receipt more than \$60 from a specialty store or \$120 in a major store (Major stores: Coles or Woolworths). E.g. if the total receipt is \$600, only one entry is permitted.
10. Existing subscribers of the Dianella Plaza email database are eligible to enter this competition in accordance with the entry terms listed above.
11. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its

sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved. 13. Three (3) additional reserve entries ("**Reserve Winners**") per Prize will be drawn and recorded in the order that they were drawn in case an invalid, ineligible, or uncontactable entrant is drawn.

The Promoter, the Centre, owner/s and their associated agencies, related companies, officers, employees and contractors are not liable (including in negligence) for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death which is suffered in connection with this Promotion or the use of any prize, except for:
  - a. any liability which under statute cannot be excluded; and
  - b. any liability which is caused by the negligent, reckless or intentional act or omission of the abovenamed parties.
44. The Promoter reserves the right to verify the validity of entries and entrants (including an entrant's identity, age, place of employment and residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered.
