



## Free Box Of Chocolates – Mother’s Day Promotion

### Terms and Conditions

1. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is the manager of The Dianella Plaza Shopping Centre, Greenpool Management Co Pty Ltd ACN 646 523 122 of C/o: Dianella Plaza Shopping Centre, 366 Grand Promenade, Dianella WA 6059 (“Promoter”).
3. Entry is only open to WA residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, Dianella Plaza Shopping Centre, tenants, and their employees (and their immediate families) and agencies associated with this promotion are ineligible to enter.   - a. Spend \$30 or more in one transaction at any participating Dianella Plaza specialty store, (See appendix for list of retailers) (not including alcohol, tobacco, vape equipment, weapons, gambling, purchase of gift cards, cosmetic or surgical procedures, health rebates, or medicines).
  - b. Complete the entry form on the Dianella Plaza website Mother’s Day promotional page.
  - c. Present the ‘Thank You’ message received on completion of the entry form, Photo ID, and the original store receipt as proof of purchase to the hostess in the mall between 10am and 1pm each day.
  - d. Only one receipt per entry is permitted.
  - e. The same receipt cannot be used for multiple entries.
  - f. Multiple entries are not permitted.
